OUR STORY

The Club at the Strand began operating in November 1997 as a full-service 27 Hole private country club ideally located in the prestigious North Naples area at Immokalee Road and I-75. Members fancy our beautiful 55,000 sq. foot Clubhouse offering multiple indoor and al fresco dining venues. Experience outdoor dining while witnessing sweeping views of the golf course from the Veranda, the exquisite Botanical Gardens, or the new Tavern 59. The Island Bar is located in the resort-style pool area. Special to the Club's history was hosting the LPGA in both 1997 and 1998.

Golf members enjoy three 9 Hole courses, each offering their own personality; the Preserve Course is considered the most challenging due to its natural layout. The Savannah Course offers wide sweeping fairways and the largest greens of the onsite courses. Finally, the Sabal is our signature course with unique characteristics designed for each hole. Golf operations are led by a PGA staff with a full golf event calendar for men and women.

The Strand offers eight HydroGrid Har-Tru tennis courts - half of which are available for evening play, plus seven Pickleball courts - also available in the evening. Members enjoy the Bocce Center with three courts, two basketball courts, and a croquet court. Individual lessons, open play, and league options are available for all court sports.

The Fitness Center offers a vast assortment of lifestyle choices from a wide selection of aerobic equipment, weight machines, and free weights as well as an abundance of exercise classes. Personal training with certified trainers allow members to meet their goals. The Spa invites relaxation through a selection of treatments. Strand members take great pride in the friendly club environment and relish the opportunity to create lifelong friendships.

SOCIAL Initiation Fee: \$10,000 | Annual Dues: \$4,162

SPORT Initiation Fee: \$40,000 | Annual Dues: \$7,652

This family membership allows for **limited** golf privileges.

Winter Months: November 1 through April 30

Golf is allowed a total of 12 times per family member. Guest fees are applicable for play during this time. Practice is allowed after 1PM on days without a tee time. No tournament, event, or league play is allowed.

Summer Months: May 1 through October 31

Unlimited use of the golf courses and practice areas are permitted. Cart fee is applicable for play during this time frame. Reciprocity is available.
