Mosque Mediation Programme (Basic Course for Mosque & Community Mediators) – 2024

Ethical behaviour, social responsibility, and integrity in dispute resolution are fostered through this programme, reflecting a commitment to building harmonious communities through structured and values-based mediation practices.

The initiative to strengthen ethical values in community conflict management was conducted at Masjid Al Syakirin, Gombak, with 14 participants on 27 October 2024. The course introduced participants to the fundamentals of mediation as an alternative dispute resolution method grounded in fairness, neutrality, and justice. Emphasis was placed on handling conflicts ethically, promoting dialogue, and encouraging peaceful resolutions within the community.

From an ethical perspective, the initiative reflects strong values of social responsibility, equitable access to education, and integrity in knowledge sharing, reinforcing SBE's commitment to inclusive and ethical community engagement. This programme, held on 25 January 2024 at SK Bombalai, was an initiative aimed at empowering the local community, particularly school students, through knowledge transfer and motivational engagement. The programme not only enhanced participants' educational awareness and aspirations but also contributed to supporting asnaf communities.

From an ethical perspective, the session highlighted key principles such as justice, fairness, honesty, and ethical conflict resolution, aligning with broader values of integrity, social responsibility, and ethical governance in economic systems. Dr. Hanna Ambaras Khan represented SBE at the Asia World Muslim Summit 2024, held on 22 March 2024 in Kuala Lumpur, where she delivered a presentation titled “The Application of Amicable Settlement in Islamic Economy,” coordinated by Nurzatul Hakimah Mahmud Mahayudin. The presentation emphasised the importance of amicable dispute resolution within the framework of Islamic economics.



Global Goals Youth Summit 2024



From an ethical perspective, the summit emphasised values of sustainability, social responsibility, global awareness, and societal impact, fostering an ethical mindset among youth in addressing contemporary global challenges.

Held on 25 January 2024 in Kuala Lumpur under the leadership of Saadiatul Ibrahim and coordinated by Nurzatul Hakimah Mahmud Mahayudin, this programme served as a platform focusing on global issues aligned with the Sustainable Development Goals (SDGs).



Self-Development and Sustainable Ecosystem Programme 2024



From an ethical perspective, the session fostered a sense of responsibility among participants towards the impact of human activities on the ecosystem, encouraging environmentally conscious and ethically responsible behaviour.

A presentation by Dr. Hanna Ambaras Khan highlighted the importance of self-development aligned with environmental sustainability awareness. The programme emphasised ethical values such as environmental responsibility, sustainable practices, and integrity in resource management.

Overall, these initiatives reflect SBE's commitment to developing graduates who are not only competent, but also principled and ethically grounded. The sessions highlighted that ethics is not merely about compliance with rules but forms the foundation of professional conduct in both academic and future workplace settings. Students were exposed to key concepts such as ethical behaviour, adherence to institutional standards, and the role of governance in ensuring transparency and trust. Throughout 2024, SBE organised two sharing sessions by Dr. Hanna Ambaras Khan, Assistant Dean (Ethics, Sustainability & Governance), titled "Ethics & Compliance" and "Integrity in Action: Ethics and Compliance for Sustainable Success." These sessions introduced students to the importance of ethical awareness from the beginning of their academic journey, with emphasis on integrity, accountability, and responsible decision-making.

MEDIATIO ARTIUM – AIKOL & AIAC 2024



This programme reflects SBE's commitment to advancing ethics, governance, and responsible professional practice beyond the classroom. Dr. Hanna highlighted that integrity and professionalism are essential in building trust and ensuring fair outcomes in dispute resolution, with strong emphasis on the ethical foundations of mediation, including neutrality, confidentiality, impartiality, and informed consent.

Held on 7 December 2024 at the Asian International Arbitration Centre (AIAC), this workshop brought together 60 IIUM (AIKOL) law students for practical exposure to mediation as an alternative dispute resolution mechanism. Dr. Hanna Ambaras Khan, Assistant Dean (Ethics, Sustainability & Governance), SBE, Universiti Putra Malaysia, was invited as the guest speaker. The session focused on the mediation process, its legal relevance, and key mediator skills.
