QUALITY & SAFETY PHARMACY PROGRAM

As community pharmacy continues to strengthen its role as a central pillar of Australia's primary healthcare system, the expectations placed on pharmacies are evolving. Pharmacies are now delivering a broader range of clinical services, including vaccinations, medicines checks, chronic disease support and other patient-facing care. With this expanded role comes the need for stronger systems, better governance, improved clinical oversight and more consistent ways to demonstrate quality, safety and compliance.

The transition from the Quality Care Pharmacy Program (QCPP) to the Quality and Safety Pharmacy Program (QSPP), aligned with AS 85000:2024 and the National Safety and Quality Primary and Community Healthcare Standards, represents an important step forward for community pharmacy. This interactive workshop will explore how digital systems and technology can support pharmacies on their journey to QSPP accreditation - not as an additional burden, but as an enabler of safer, smarter and more efficient practice.

The session will look at how technology can help embed clinical governance into daily pharmacy workflows, support documentation and evidence requirements, strengthen operational consistency, and reduce duplication across teams. It will also explore what pharmacies should be thinking about when reviewing or selecting digital solutions, including interoperability, conformance, cyber security, privacy, data quality and future readiness.

Importantly, this workshop will take a practical and agnostic approach. It will focus on the capabilities, considerations and questions pharmacies should be asking, rather than a single system or vendor. Participants will leave with a clearer understanding of how digital tools can support QSPP preparation, what good technology enablement looks like in practice, and how technology can become a foundation for stronger workflows, better governance and the continued delivery of high-quality patient care in community pharmacy.

This practical and engaging session equips pharmacy assistants with foundational knowledge to support patients preparing for travel and recognise when referral to the pharmacist is required. 10.00am - 10.40am		 Community pharmacy and the expanded role in Women's Health From January 2027, a new Commonwealth Government pharmacy trial will enable concession card holders to access more affordable contraceptives and treatment for uncomplicated urinary tract infections prescribed by appropriately trained pharmacists, outside the PBS. To deliver these services safely and effectively, pharmacies will need clear implementation plans, covering additional pharmacist training, suitable consultation spaces, and the use of clinical software. A five-step pharmacist pathway for paediatric ear infections

This session tackles a persistent issue in paediatric care - the overreliance on antibiotics for ear infections. Structured around a five-step, guideline-led management pathway aligned with the Queensland expanded scope framework, John Bell will demonstrate how pharmacists can lead effective care for acute otitis media and acute otitis externa presentations in children. With a strong focus on anti-inflammatory analgesia as the cornerstone of treatment, building skills in managing parental expectations, and defining clear thresholds for referral, attendees will leave with practical strategies to deliver confident, evidence-based management, and meaningfully contribute to antimicrobial stewardship in the community.

Refresher Training Part II: Paracetamol use and safety in pharmacy practice

Paracetamol is one of the most commonly used medicines for pain and fever, and pharmacy assistants play an important role in supporting safe and appropriate use, particularly when assisting patients with product selection. This training program provides pharmacy assistants with foundational knowledge about paracetamol, including how it is used, common indications, available formulations, and key safety considerations. Participants will explore the role of paracetamol in managing pain and fever across different patient groups, including adults, children, older people and people with complex health needs. Core content covers safe dosing principles, the risk of accidental double dosing, combination products, modified-release formulations, and the importance of checking other medicines that may also contain paracetamol. The session will also explore common patient scenarios, such as selecting products for cold and flu symptoms, children's fever, acute pain and ongoing pain. Pharmacy assistants will build practical capability in recognising when to refer to the pharmacist, including suspected overdose, persistent pain or fever, use in young children, pregnancy or breastfeeding, liver disease, heavy alcohol use, and uncertainty about dosing. The session reinforces the pharmacy assistant's role in providing safe product information, supporting medicine safety, and escalating clinical concerns appropriately.
