Winnebago Tribe Celebrates Land Back After 54-Year Fight

[Winnebago, NE] Over half a century of legal, political, and spiritual endurance culminated on Saturday, August 8, 2026, as the Winnebago Tribe of Nebraska hosted its official Land Back Celebration at the WinnaVegas Casino Resort Event Center. The historic event honored the return of approximately 1,600 acres of

reservation land along the Missouri River, which was unlawfully condemned by the U.S. Army Corps of Engineers in 1970.

The day commenced at 10:00 AM with a sacred land blessing and prayer ceremony rendered by Winnebago Combat Veteran Larry Payer. The blessing and prayer took place directly on the recovered Iowa acreage, marking the first time in generations that tribal members could legally stand on the territory as its rightful stewards.

Following a community luncheon, the formal program opened with the posting of colors by members of the Winnebago Veterans Association, Sam Prue, Ray Thomas, Anthony Bassette Jr., and Mike Walker, accompanied by singing of the flag and welcome songs by Winnebago drum group, Greywolf Singers.

The legislative victory was made possible by the passage of the Winnebago Land Transfer Act (H.R.

Winnebago Tribal Council Addresses Recent BIA Human Trafficking Operation



The Winnebago Tribal Council issues this official statement to address and correct inaccurate rumors circulating in the media regarding a recent multi-agency law enforcement operation addressing human trafficking. First, the Winnebago Tribal Council is exceptionally proud of the Winnebago Tribal Police Department and our law enforcement partners for their proactive work in keeping our properties, our people, and the broader region safe.

We want to send an unmistakable, zero-tolerance deterrent message: Criminal activity, human trafficking, and the exploitation of the vulnerable will not be tolerated anywhere on or around our tribal properties and jurisdictions. Law enforcement will continue to utilize every available resource—local, state, tribal, and federal—to track down, arrest, and prosecute offenders to the fullest extent of the law. Our information was that a human

trafficking operation was based at WinnaVegas Casino (located in Sloan, Iowa). Because WinnaVegas is owned and operated by the Winnebago Tribe, news headlines broadly referenced "Winnebago," which unfortunately led to confusion and false assumptions locally. Furthermore, none of the individuals arrested or involved in these crimes are members of the Winnebago Tribe.

1240), championed by Senator Deb Fischer, Representative Randy Feenstra, and Representative Sharice Davids. Signed into law by President Joe Biden on July 12, 2024, the Act permanently places the 1,600 acres into federal trust. Per tribal and federal mandates, the land is strictly designated for non-gaming purposes and will be managed by the Winnebago Wildlife and Parks Department for conservation, habitat restoration, and tribal hunting.

While the official paperwork is signed and sealed, the heart of Saturday’s celebration was found in the shared memories of the people who refused to let an injustice stand. Our storytelling traditions were on full display, reminding everyone in the room that we didn’t just fight with law briefs, we fought with resilience, humor, and heart.

Winnebago Tribal Vice-Chairman Eugene DeCora Sr. shared the history of the “Winnebago Navy,” originally captured in Reuben Snake’s book, Your Humble Serpent. Born out of pure defiance in 1970 after the Army Corps of Engineers and the State of Iowa illegally seized tribal land for a \$13 million water park, the Winnebago Navy was launched. Lacking actual vessels, leaders Louis LaRose, Reuben Snake Jr., and Sterling Snake borrowed a 14-foot runabout and a 12-foot aluminum rowboat to cross the mighty Missouri River and plant “NO TRESPASSING” treaty signs.

The room overflowed with emotion as current leaders looked back on the generational sacrifice that brought the tribe home. Winnebago Tribal Chairman Coly Brown delivered a speech, noting that he was just a two-year-old toddler when this fight began 54 years ago. He reminded the youth in attendance that our connection to this land along the Missouri River is permanent and can never be erased by changing federal policies.

Councilwoman Victoria Kitcheyan spoke of the deep emotion of traveling

to Washington, D.C., to view the original physical treaties. She described looking at the X’s and fingerprints of past Chiefs who couldn’t read or write but sacrificed everything to secure a homeland for us. “We take that trauma, we take that pain, and we turn it into love,” Kitcheyan stated, explaining how that diplomacy ultimately won over lawmakers in Washington.

Winnebago Tribe’s General Counsel Danelle Smith received recognition, along with a standing ovation from the community. Growing up in Winnebago, Smith said she looked around her community and wanted to understand why things were the way they were. She went to law school specifically to learn how to navigate and dismantle the very legal systems that had been used against our people for centuries.

Following the look back at our history and legal battles, the celebration shifted into a showcase of living Ho-Chunk culture. Winnebago Tribal Member and Award-Winning Composer Tyler Free-LaMere performed her musical piece titled “My Heart is Strong,” which perfectly captured our people’s long fight and ultimate triumph. Then, Winnebago Youth stepped out and performed different dance categories. Their traditional styles, vibrant regalia, and amazing footwork that brought the historic significance of the day to life through movement.

The formal program concluded with a powerful closing ceremony of recognition with two honor songs rendered by Greywolf Singers. The honor songs were rendered to officially recognize all the tribal council members who have served throughout this 54-year fight, as well as the families of those council members who supported them. To initiate this tribute, Greywolf Singers rendered the George Snake song and the Mallory song, offering a sacred conclusion to a milestone day of sovereign resilience along the Missouri River.

Key Facts Regarding the Operation:

Location: Although the initial operational plan focused on WinnaVegas Casino in Sloan, Iowa, investigators modified the plan to make contact with the subjects in the Village of Winnebago, Nebraska. Investigators did not conduct the operation in residential neighborhoods; the subjects were contacted and subsequently apprehended at a location away from residences to minimize any potential risk to the public and to ensure the operation was conducted in the safest manner possible.

Suspects: No tribal members were involved. All arrested suspects are non-tribal members from outside our community.

Law Enforcement Partnership: The operation was a coordinated multi-jurisdictional effort led by the Bureau of Indian Affairs (BIA) Predatory Crimes Unit and the Winnebago Tribal Police Department, alongside federal, state, and local partners, to target predatory crimes.

Victim Support: One adult female victim was successfully recovered on the scene and immediately provided with necessary support services.

‘Am I my brother’s keeper?’

Then Mauna said to Cain, “Where is your brother Abel?” “I don’t know,” he replied. “Am I my brother’s keeper?” [Genesis 4:9 (NIV84)]

If you know this story from Mauna’s Sacred Word then you will be able to answer this question: Did Cain know where his brother Abel was? A follow up question: Did Mauna know where his brother was?

I will begin with the follow up question. Did Mauna know where his brother was? The answer is a resounding ‘yes!’ Creator God certainly did know where Abel was. Then why do you think Mauna asked Cain this question?

Mauna asked “Where is your brother Abel?” so that Cain might fess up to what he had done. When one is confronted by another with a wrong, that he or she did, it is best to take responsibility. This goes against one’s nature - one’s sinful nature. When confronted by Mauna Cain lies thus adding to his wicked ways and actions.

The answer to my first question: Did Cain know where his brother Abel was? The answer was surely he did. How do we know this? Just prior to Mauna asking the question of “Where is your brother Abel?” Cain had asked his younger brother Abel to go out to the field. While they were in the field Cain attacked his brother and killed him. Cain killed his brother and knew full well where he was - where his dead body lay or where he had buried him.

Then Cain was so bold, so brash, so arrogant to ask Mauna “Am I my brother’s keeper?” Mauna confronted Cain “What have you done? Listen! Your brother’s blood cries out to me from the ground. [Genesis 4:10 (NIV84)].

The blood of Abel cried out from the ground demanding vengeance! What had Abel done to deserve such a death? Actually it was what Cain had done that led up to this tragedy.

One must go back further in this story. ‘Now Abel kept flocks, and Cain worked the soil. In the course of time Cain brought some of the fruits of the soil as an offering to Mauna. But Abel brought fat portions from some of the firstborn of his flock.

Mauna looked with favor on Abel and his offering, but on Cain and his offering he did not look with favor. So Cain was very angry, and his face was downcast.

Then Mauna said to Cain, “Why are you angry? Why is your face downcast? If you do what is right, will you not be accepted? But if you do not do what is right, sin is crouching at your door; it desires to have you, but you must master it.” [Genesis 4:2b–7 (NIV84)] inserting Mauna in place of ‘the LORD’].

Mauna was WARNING Cain! Cain did not heed Mauna’s warning. Many today do not heed Mauna’s countless warnings - but would rather do things their way - forsaking the wise advice of Mauna and his pastors & teachers.

Mauna’s Sacred Word reveals what made Abel’s sacrifice acceptable, and what Cain’s sacrifice lacked. We turn to the book of Hebrews: ‘By faith Abel offered God a better sacrifice than Cain did. By faith he was commended as a righteous man, when God spoke well of his offerings. And by faith he still speaks, even though he is dead’ [Hebrews 11:4 (NIV84)].

Cain lacked faith. He was merely going through the outward motions of offering up a sacrifice. Without faith it is impossible to please God or for him to say to you “pinagigi” - ‘you have done well,’ or ‘with you I am well pleased!’

Abel’s blood cried for vengeance. However the blood of another, a member of the tribe of Mauna’s chosen people and his dearly loved son, provides a better word.

Again we turn to the book of Hebrews: ‘You have come to God, the judge of all men, to the spirits of righteous men made perfect, to Jesus the mediator of a new covenant, and to the sprinkled blood that speaks a better word than the blood of Abel’ [Hebrews 12:23b–24 (NIV84)].

The blood of Jesus offers FULL and COMPLETE payment for the sin of the world. To each and every one who places his/her faith in Jesus receives the forgiveness of one’s sin and the hope and the promise of everlasting life!

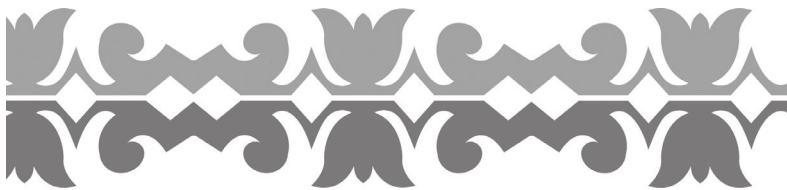

Community Notice:
Positive West Nile Virus Mosquito Sample Detected

The Winnebago Tribe of Nebraska has been notified that a mosquito sample collected within the community boundaries of the Winnebago Tribe of Nebraska has tested positive for West Nile virus.

At this time, this means the virus has been detected in a mosquito in the boundaries of the Winnebago Tribe of Nebraska. It does not mean that a human case has been identified in our community. However, the positive test serves as an important reminder to take precautions to reduce the risk of mosquito bite.

Residents are encouraged to:

- Use an EPA registered insect repellent (with Deets) when spending time outdoors. DEET is considered the suggested standard for insect repellent because it provides long-lasting, broad spectrum protection against mosquitoes, ticks, and other biting bugs by disorienting their sensory receptors so they cannot locate humans.
- Wear long sleeves and long pants, especially during dawn and dusk when mosquitoes are most active.
- Remove standing water from around your home, including buckets, bird baths, flowerpots, gutters, and other containers where mosquitoes can breed.
- Ensure windows and doors screens are in good repair to help keep mosquitoes out of your home.

The Māḱa cīṇaḱ wōgijire ra (Winnebago Public Health Department) will continue to monitor mosquito activity and work continue to work with other local public health partners as appropriate.

Most people infected with West Nile virus do not become ill, but may develop symptoms such as fever, headaches, body aches, rash or fatigue. In rare cases, serious neurological illness can occur. Anyone experiencing severe symptoms should seek medical attention immediately.

We appreciate everyone’s cooperation with helping reduce mosquito breeding sites and protect the health of our Village. The Winnebago Tribe of Nebraska is providing public notice of its proposed Statement of Activities for a pre-application to the U.S. Department of Agriculture (USDA) Rural Development Fiscal Year 2026 Housing Preservation Grant (HPG) Program.

The Winnebago Tribe of Nebraska proposes to request \$19,249 in FY2026 Housing Preservation Grant funds to support the Tribe’s Senior Home Improvement Project. The project is a homeowner assistance program designed to preserve and improve adequate housing for eligible low- and very-low-income senior citizen homeowners residing within the exterior boundaries of the Winnebago Indian Reservation. This continues the purpose of the Tribe’s previous Senior Home Improvement Project.

The proposed program will provide assistance for eligible home repairs and rehabilitation activities intended to improve the safety, condition, accessibility, and habitability of existing homes. Proposed activities may include:

- Installation and/or repair of sanitary sewer and waste disposal systems;
- Water softener/reverse osmosis systems;
- Energy conservation measures, including insulation, storm windows, and screen doors;
- Repair or replacement of heating systems;
- Repair of structural supports and foundations;
- Repair or replacement of roofs and gutters;
- Accessibility improvements; and
- Necessary repairs to manufactured housing.

These are the types of eligible repair activities included in the Tribe’s proposed Statement of Activities.

Eligible recipients will be selected in accordance with applicable USDA Housing Preservation Grant requirements and the requirements of the Winnebago Tribe’s Senior Home Improvement Project. The proposed program will serve eligible homes located within the geographical boundaries of the Winnebago Indian Reservation.

WCHS Receives IHS Staff Quarters Grant
to Support Employee Growth

Winnebago, NE – The Winnebago Comprehensive Healthcare System (WCHS) is pleased to announce that it has been selected to receive an Indian Health Service (IHS) Staff

Quarters grant to support the development of additional staff housing on the Winnebago Reservation.

The funding is part of the FY 2026 IHS Staff Quarters initiative, which provides resources to support healthcare organizations by addressing critical employee housing needs. The IHS Division of Facilities Planning and Construction received 22 proposed staff quarters projects from 6 IHS areas totaling more than \$111 million in requested funding. After reviewing and ranking, 8 projects were selected nationwide to help address healthcare workforce housing needs.

WCHS was selected as one of the healthcare organizations to receive this investment, which will allow for the construction of a fourplex consisting of small, efficient one-bedroom, one-bathroom units designed to support healthcare recruitment and retention. The need for additional staff housing comes as healthcare services in Winnebago continue to grow due to health needs and

chronic conditions. To meet this demand, WCHS has expanded its workforce from approximately 199 employees to 349 employees, helping the organization strengthen access to care.

This fourplex will be developed in partnership with the Winnebago Tribe of Nebraska and its economic development organization, Ho-Chunk, Inc., through BluStone Homes. The project will build upon existing residential development and infrastructure to create efficient, accessible housing for WCHS employees.

“Having staff housing available is an important part of supporting our employees and strengthening our organization,” said Sharon Frenchman, Chief Administrative Officer. “This additional housing opportunity will help us recruit and retain talented healthcare professionals, support the growth of our workforce, and ensure WCHS can continue meeting the healthcare needs of the community.”

This project reflects WCHS’s ongoing commitment to investing in resources, facilities, and employees needed to provide compassionate, comprehensive healthcare for generations to come. WCHS would like to thank the Indian Health Service and all partners involved who helped make this project possible.

I was only a freshman, but by my second semester, he had me taking junior-level calculus, statistics, and advanced math classes. I really appreciated that he had so much faith in me.

Bethani: My favorite teacher was Mr. Marc LaDue! He taught history at Winnebago Public School and was one of the most realistic teachers I ever had the opportunity to learn from. He gave me a lot of motivational speeches at a time in my life where I needed to hear them the most. Honorable mention, I have to give a shout-out to Mr. Mark Feight. He is another one of my favorite teachers from the public school and I hope he is living it up in retirement!

Tyler: My favorite teacher was Mrs. Patrick of SSC Cardinal Elementary in 5th grade. She was pretty cool. I remember she rode a motorcycle, wore a leather jacket, and had a short pixie cut. She was always super tan. She made reading time fun and overall was a great teacher!

Quince: My favorite Teacher growing up was the late Joan Cline. She was my middle school teacher for 3 yrs. 6th-8th grades. She was the only Native teacher at WPS. She was a Legend. And, then in High School, my favorite teacher was Mel Southwell. He was my Jr. High track coach. At our 1st trackl meeting in Columbus, NE he allowed me to compete in a track meet in 8th grade under the name Greg Bass Jr. for 4 events and then Quince Bass for 4 events. I took 1st place in 7 of 8 events and 2nd place in the last event. Out of 16 teams, I placed 3rd and the trophy is still sitting in the trophy case at WPS.

Christina: My favorite teacher was my first-grade teacher, Mrs. Anderson. She was the kindest and sweetest teacher, always ever so patient with us and fun too! I remember one time she let us make caramel apples and she would separate seating between the mean naughty kids and the well-behaved kids like myself lol.

Gayla: My favorite teacher was Mr. Marc LaDue at WPS! He was my history teacher. He was one of the few staff members who noticed when I was struggling, pulled me aside, and made special accommodations for me. That meant a lot to me, and I’ve never forgotten it. I also learned so much in his class and really appreciated the way he taught history. He didn’t romanticize it or teach it from just one perspective. He understood that history is nuanced. He saw the humanity in it, the good and the bad, and taught it in a way that made you genuinely interested in learning more. I really admired that about him. I carry his teachings with me today. One time, he caught me passing notes in class, and I was TERRIFIED because the “note” I passed was actually a sketch I had drawn of him. He looked at it, smiled, and ended up hanging it near his desk, where it stayed for the rest of my time at WPS. I also always thought it was cool that he rode a motorcycle to school every day. And I’ll never forget his Wu-Tang Clan button-down he often wore, haha. He was one of those teachers who left an impression on me, not only because of what he taught, but because of how he treated me when I needed someone to notice. He passed in 2018. He is definitely missed. RIP Mr. LaDue!

I am 26 years old, I am a descendent from the bear clan, I grew up in Winnebago. My mother is Joi Long and my grandmother is Evelyn Lucille “Star woman” Cleveland. I am glad to see each of you today, Thank you.

Around this time of the Homecoming celebration it’s important to remember that we are honoring and commemorating Chief Little Priest and the Company “A” scouts for their bravery and sacrifice on behalf of the Winnebago people. I am also reminded of my great grandfather Paul Bearskin Logan and my grandpa Robert Lieb as they both served in the Army. On my maternal side my great grandparents are Evelyn Pauline

Logan and Silas Cleveland and my mother was raised by her grandparents Harry Funmaker and Evelyn Pauline Logan in Lyndon Station, WI. I am the youngest daughter of the family and my father is from the Navajo Nation in Birdsprings, Arizona. I am going to be graduating from the University of Nebraska-Omaha with my bachelors in Political science and minors in Native American Studies and Philosophy. I’ve been recognized on the Dean’s List for 3 semesters in a row and compete in pow-wows all across the country. My next goal in life is to head to law school and continue my education journey so I can help uplift not only my tribe but others as well. Being asked to be this year’s head woman is a special moment and a huge honor not only for me but my family as well. I am deeply humbled and honored to be selected as this year’s 160th Homecoming Celebration Head Man dancer here in Winnebago, Nebraska. This opportunity means a great deal to me because it represents my family, our community, our culture, and the many teachings that have guided me throughout my journey.

My parents, Dorcee Kearnes and Matthew Cleveland Jr., have always been some of my greatest teachers. From an early age, they showed me the importance of respect, kindness, hard work, and the values needed to walk through life with a good heart. My mother and I are very close; she was my main source for strength, motivation, and encouragement. My grandparents, Matthew Cleveland Sr., Violet Lasley Cleveland, Richard Kearnes Sr., and Loylee Likehim Kearnes, also played an important role in shaping who I am today. They are the main reason why I agreed to be this year’s Head Man dancer so they can look back one day and watch what their dad has done. I want to thank their mother, my fiancé, Allie Robinson, for carrying these beautiful souls into my world.
